

Talata Basketball Articles of Association

Talata Basketball's articles of association of 14.11.2024, approved at the Extraordinary General Assembly on 14 November 2024.

Changes to the articles of association can only be made at a General Assembly and follow the guidelines set out in §6.

The articles of association were most recently amended:

§ 1 The association's name and registered office

The association's name is Talata Basketball (hereinafter referred to as Talata).

Talata's home is Copenhagen.

Talata is a member of DBBF (Danmarks Basketball Forbund) and EYBL (European Youth Basketball League) as well as DGI (Danske Gymnastik- og Idrætsforeninger) and other associations and organizations that the board deems relevant to Talata.

§ 2 Purpose

Talata's purpose is to promote basketball as a sport, community and personal development among people primarily in the 10-40 age group. Through association activities, we strive to create a safe and inclusive environment where members develop within a personal skills level and within basketball as a sport.

Talata is an ambitious club on their own and athletes behalf, resting on three core values; Pursuit of Excellence, Joy and Mutual Respect.

Pursuit of excellence

We believe in the relentless pursuit of personal and team growth. We strive to reach our full potential on and off the court, with a special emphasis on your personal development. We embrace challenges, learn from mistakes, and celebrate achievements.

Joy

We believe basketball is not just a game, but a source of joy and passion. We celebrate the thrill of competition, the camaraderie of teamwork, and the sheer fun of playing the game we love. We want every moment on the court to be filled with passion and excitement.

Mutual Respect

We believe in treating everyone with utmost respect and dignity. We value diversity, inclusivity, and fair play, recognizing the unique contributions each individual brings. We foster a culture of sportsmanship, where opponents are respected and teammates are supported, ensuring everyone feels valued.

§ 3 Membership

You are a member if you pay your membership fees on time, have no other financial arrears with Talata and have received the board's commitment to admission. Minors wishing to become members of Talata require the consent of a parent or guardian.

The following membership types are admitted: Active members.

Active members of Talata

Children, young people and adults aged 10-40 and applies to the athlete himself, who is hereby given the opportunity to participate in all Talata's activities, as well as represent Talata to DBBF (Denmark's Basketball Federation) to be considered for participation in International and National tournaments, matches and so on.

Every active member has the right to vote if they meet the conditions for this and the right to vote applies to every member who is 15 years old. Members under the age of 15 are represented by one of the members' parents.

§ 4 Fees for membership

Fees for membership and participation in Talata's activities are determined based on the individual activities and may vary. The annual fee is charged half-yearly and is binding for the current half-year.

Membership fee is set at the general meeting.

§ 5 Deregistration of Membership & Exclusion

Deregistration of membership is valid when this has been communicated in writing to Talata's treasurer with a minimum of 14 days' notice, without the possibility of a full or partial refund of the prepaid subscription.

If a member is in arrears beyond the set deadline, that person may be deleted without prior notice.

A former member who is excluded due to dues arrears cannot be re-admitted as a member until the debt is paid to Talata.

The board can exclude a member when special circumstances give rise to this. The member can demand that the question of exclusion be decided at the next ordinary general assembly

meeting. The issue of exclusion must be included as a separate item on the agenda. The decision is only valid if at least 2/3 of the voting members present vote in favor.

§ 6 Ordinary General Assembly

The ordinary general assembly meeting is held once a year, before the end of May. The general assembly is Talata's highest authority, and convening is done in writing with at least 14 days' notice.

If you have proposals that you want the general assembly to adopt, they must be in the hands of one of the board members no later than 8 days before the general assembly is held.

Decisions are made by simple majority. In the event of a tie, the chairman of the board has the deciding vote.

The agenda for the annual ordinary general meeting must include at least these items:

- Election of meeting conductor and two vote counters (not members of the board)
- Presentation of Talata's report
- Submission of audited accounts for approval
- Determining the membership fee
- Approval of the budget
- Processing of incoming proposals
- Election to the board of directors
- Election/re-election of the auditor
- Is there a need for changes in the articles of association?

The meeting conductor signs the minutes.

§ 7 Extraordinary General Assembly

An extraordinary general assembly meeting can be called when a majority of the board or at least 25% of the voting members so request in writing from the board.

An extraordinary general assembly meeting is held no later than 4 weeks after a written request has been submitted to the board with information on the topic that is to be discussed.

Items for the extraordinary general assembly meeting appear in the notice.

§ 8 The Board

Talata is managed by a board consisting of 3-6 members, who are elected at the general assembly meeting. The general assembly meeting is Talata's highest authority and must elect a chairman, deputy chairman, treasurer, auditor, deputy auditor and board deputy.

The board constitutes itself on the other positions and can continuously change the task areas between them. The board takes care of the day-to-day management and makes decisions in accordance with the articles of association.

Voting members, who are members over 15 years of age, can be elected to the board.

The board is re-elected by the general assembly meeting. The chairman and half of the ordinary board members are elected in even years. The vice-chairman, treasurer and half of the ordinary board members are elected in odd-numbered years. The election period is 2 years. If a board member resigns during the election period and the board then consists of fewer than 5 elected members, the board can supplement itself until the next general assembly meeting.

The position as a board member is unpaid.

The board is called to a meeting when the chairman or at least 2 board members so wish. The board is only competent to make decisions when a majority of the board members are present.

The board is free to invite guests to all or parts of the board meetings.

Minutes must be taken of each board meeting. The minutes must be approved at the next board meeting.

Decisions are made by simple majority. In the event of a tie, the chairman has the casting vote.

§ 9 Subscription rights / Power of Attorney

The association Talata is underwritten by the chairman and the treasurer jointly. The board can grant power of attorney to other members of the board as needed.

§ 10 Dissolution of the association

Dissolution of the association Talata can only take place at an extraordinary general assembly meeting, where at least 2/3 of those present vote for dissolution. Any assets upon dissolution must be transferred to another non-profit association that works for similar purposes.
